3. Printed copy of application along with documents uploaded online are required to be submitted to concern Additional Chief Engineer-cum-Electrical Inspector office where the online application was submitted by **07/09/2024, 05:00PM**.
4. Candidates must ensure their eligibility before applying.
5. Candidates need to upload scanned copy of required documents during the online application process.
6. Candidates meeting the eligibility requirements only shall be shortlisted.
7. No individual admit card will be sent to candidates by Post for appearing the Examination.
8. The shortlisted candidates shall be intimated by SMS / E-mail and have to download the admit card from e-district portal by logging user name and password. The list of shortlisted candidates shall also be published in our official website <https://eicelectricityodisha.nic.in>.
9. These candidates shall have to furnish the original documents for verification on the date of the examination.
10. In case of any discrepancy between the documents uploaded (with the online application) and the original documents submitted for verification, the applicant shall be disqualified.
